Hold Harmless Clause and Insurance

All authorized vendors participating in the Town of Kernersville Farmers Market shall be individually and severally responsible to the Town of Kernersville and the Rotary Club of Kernersville for any loss, bodily or personal injury, deaths and/or property damage that may occur as a result of the vendor's negligence or that of its servants, agents and employees. All vendors hereby agree to indemnify and save the Town of Kernersville and Rotary Club of Kernersville, their officers and employees harmless from any loss, cost, damages and other expenses, including attorneys' fees, suffered or incurred by the Town of Kernersville or Rotary Club of Kernersville by reason of the vendor's negligence or that of its servants, agents and employees; provided that the vendors shall not be responsible nor required to indemnify the Town of Kernersville or the Rotary Club of Kernersville for negligence of the officers or employees of the Town of Kernersville or Rotary Club of Kernersville. No insurance is provided by the Town of Kernersville or Rotary Club of Kernersville to participants in the Town of Kernersville Farmers Market.
